- Update on HOA and Wastewater Assessments (Tabitha/Deanna)

- Lost Creek Water Association (LCWA) repairs update (Cindy)
  - Still need to paint graffiti on water tower; LCWA plans to take care of this in the
     Spring
  - LCWA recently formed a Board of Directors; Cindy is trying to get Wild Ridge a seat on this board; WR has a significant portion of the lots serviced by LCWA; we need to get involved; still working it
- TruGreen Update (Dale)
  - o Contract executed; CLOSED
- Landscaping Update (Cindy Bergman)
  - Planned to get bids for two Phases to improve the entrance area:
    - Phase 1: Area around the Wild Ridge Estates sign
    - Phase 2: extend the area in front and into the water collection area
  - Contacted 5 landscapers; all came out and 3 provided a response
  - Lowest bid was \$6.5K for Phase 1 & 2 (complete area); next best was \$10K for just
     Phase 1
  - We have the budget carried over from prior years from "HOA Improvement" that was approved for use at the 2022 General Membership Meeting
  - Motion to Approve pursuing the lowest bid | Dale / Tabitha 2d
    - Tabitha brought up that we need the contractor to be licensed, bonded, and insured. Dale added that WR needs to be added to their insurance
    - Board voted unanimously to approve with that condition; Cindy will contact the contractor and report to the board on progress
- HOA Governance Changes Update (Tim)
  - Tim and Larry Grenon worked on a process to collect proposed changes to HOA
     Governance documents; Tim will put the document out to collect proposed changes,
     host a meeting to discuss and prioritize, and present at the HOA General
     Membership Meeting
- Association Compliance Update (Steve/Deanna)
  - Monthly compliance check completed on March 23d

- o Ex-Cell will send out the first notice letters on behalf of the Board
- o Clarification requested: Garbage can screening and placing/returning from the curb
  - Deferred to the Governance review to clarify or update
